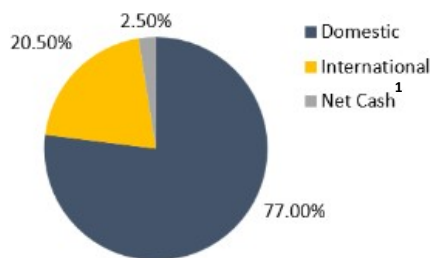

GEOGRAPHIC DIVERSIFICATION

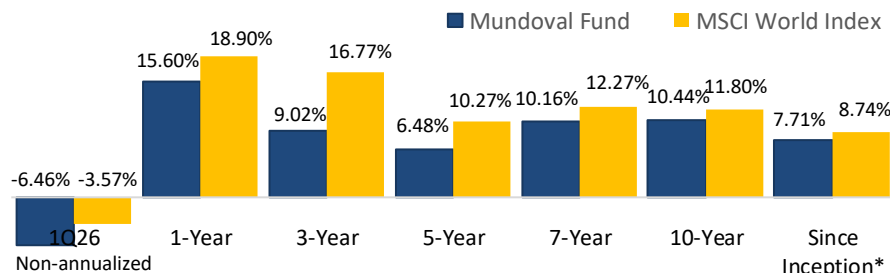

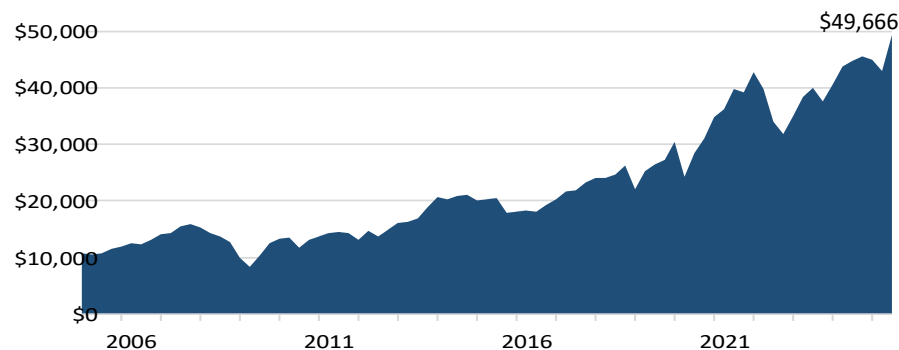
