What happens when you limit sharing for an account you hold jointly?	Your choices will apply to everyone on your account—unless you tell us otherwise.									
Definitions										
Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies.									
Non-affiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.									
Joint marketing	A formal agreement between non-affiliated financial companies that together market financial products or services to you.
